WHEREAS following the disastrous fire that swept through two Glebe streets on November 7, 1999 media outlets have started to report on the occurrence of all fires in Ottawa;

AND WHEREAS media reports on fires is likely attributed directly to renewed interest in fires due to the Glebe fire:

AND WHEREAS the Deputy Fire Chief has advised the Commissioner of Community Services that the number of fires in Ottawa this past weekend is not totally out of the ordinary;
