SUBJECT/OBJET HOMELESSNESS INITIATIVES FUND

ALLOCATION DECISIONS

PURPOSE

The purpose of this report is to provide the committee with the decisions of the Homelessness Initiatives Fund Allocation Committee.

BACKGROUND

In 1998, the Ministry of Community and Social Services announced the introduction of a Homelessness Initiatives Fund for the province of Ontario. The amount of \$210,000 was allocated for the Region of Ottawa-Carleton.

In a report to the Community Services Committee (5 January 1999; *Update on Homelessness*) it was indicated that the first allocation of this fund would occur early in 1999. Priorities for the first allocation were developed in collaboration with the Ottawa-Carleton Alliance to End Homelessness and submissions were invited from the community. The proposals were reviewed by an Allocations Committee comprised of Social Services and United Way staff.

The Alliance to End Homelessness supported the quick allocation these funds as one time only in 1999 so as to meet the urgent needs of persons who are homeless during the winter months.

In June of 1999 a second allocation of \$210,000 is expected from the Province. The second allocation of Homeless Initiative funds will be awarded in keeping with priorities to be determined locally through a community planning process. The Alliance to End Homelessness has agreed to work in collaboration with the Social Services between now and the summer to develop a priority setting plan for future allocations of Homelessness Initiatives Funds in the Ottawa-Carleton community. The second allocation process will occur in the fall of 1999, and it is expected to be on going funding.

Community Consultation

The Alliance to End Homelessness was consulted on the development of the funding priorities for the 1999 winter allocations. The Alliance also agreed that Social Services needed to allocate the funds as quickly as possible in order to address the needs of persons who are homeless in the winter months. The Alliance has further agreed to work collaboratively with Social Services to undertake a community planning process prior to the next allocation process.

FINANCIAL IMPLICATIONS

The Homelessness Initiatives Fund is comprised of 100% Provincial funds. The only financial implication for the Region of Ottawa-Carleton is in the administration of the funds.
