## **DEPARTMENTAL RECOMMENDATION**

That Community Services Committee nominate the following to the Ottawa-Carleton Housing Board:

-reappointees Susan MacLatchie, Trevor Heavens, Gilles Guénette, and; -two Regional Councillors.

#### BACKGROUND

Corporate Services and Economic Development Committee on February 17, 1998 referred to staff, a report that recommended the formation of a sub-committee to review applications and recommend a candidate for appointment to the Ottawa-Carleton Regional Housing Authority (now known as Ottawa-Carleton Housing or OCH). Since then, correspondence has been received from the Ministry of Municipal Affairs and Housing indicating the following changes in procedures for appointments to Local Housing Authority (LHA) boards:

- Municipalities which are being billed for social housing will now be responsible for nominating appointments to positions formerly assigned to the Province to fill as these positions become vacant. For OCH, there are 5 positions which were formerly provincial positions of which 3 are now vacant.
- Elected municipal officials are now eligible for nomination. However, municipal non-profit (MNP) board members or staff of an MNP are not eligible.

The current composition of the OCH board is shown in the attachment except that K. Ishraki has now resigned. This means that there are now 5 positions for the RMOC to fill, 3 Regional positions and 2 formerly provincial positions. Three of the incumbents are eligible for re-appointment: Susan MacLatchie, Trevor Heavens and Gilles Guénette. A letter from Ottawa-Carleton Housing which supports the reappointment of Messrs. Guénette and Heavens is attached for information.

Expeditious appointments are critical as 8 of the 13 positions are either vacant or unable to vote as their appointments have expired. The Ministry of Municipal Affairs and Housing had proceeded to re-appoint 2 incumbents (K. Ishraki and R. Stead) in order to maintain quorum but K. Ishraki subsequently resigned. The Ministry has asked that nominations be submitted by March 6, 1998.

To fill the 5 positions in the most expedient manner, it is recommended that Community Services Committee nominate the three eligible incumbents and two Regional Councillors. Other options which the Committee could consider are:

- Nominate Regional Councillors for any or all of the 5 positions; AND/OR
- Establish a sub-committee of 2 Regional Councillors to review applications and recommend nominations to Council for each of the vacant positions.

If the Committee chooses the latter option, public notices advertising the vacancies will appear in <u>The Citizen, The Sun and Le Droit</u> as soon as possible.

## PUBLIC CONSULTATION

No public consultation is considered to be required for this report.

## FINANCIAL IMPLICATIONS

There are no financial implications arising from this report.
