DEPARTMENTAL RECOMMENDATION

That the Corporate Services and Economic Development Committee approve the award of quotation for monitoring equipment, transmitters and receivers to Canguard, Ottawa, up to a maximum contract provision of \$480,000.

BACKGROUND

One of the underlying principles of the Transportation Master Plan approved by Regional Council in July of 1997 is maximizing the operational efficiency of existing infrastructure through Transportation System Management (TSM). The TSM module of the plan sets a goal of increasing system capacity by 5% through measures such as congestion management and incident management plans. Video surveillance is identified as one of the key components of these plans. The performance of the entire Regional road network is determined by the operation of its busiest and most critical intersections, including those which intersect the Transitway. Video signals from monitoring equipment at these intersections will enable staff at the Region's Traffic Control Centre to ensure optimum operation by adjusting traffic signal functions to accommodate unexpected fluctuations in traffic flow or to respond to disruptive incidents such as illegally parked vehicles or accidents.

DISCUSSION

The department is recommending the award of the contract for the supply of monitoring equipment, transmitters and receivers to Canguard up to a maximum contract provision of \$480,000.00. The recommended supplier is the sole source for the equipment in order to ensure compatibility and interoperability between the Regional Municipality of Ottawa-Carleton and existing equipment at OC Transpo and Ministry of Transportation Ontario. This will provide equipment to install approximately 25 systems.
