## **BACKGROUND**

The *Corporate Policy Manual* requires the Treasurer to report annually to the Corporate Services and Economic Development Committee on the operations of all petty cash and change funds and imprest bank accounts established under Chapter 4, Annex 4-A.

Attached is a list of petty cash and change funds and imprest bank accounts by department (Annex A) which have been established at various locations in accordance with Corporate Policy. These funds provide a cash facility to individuals when they are paying for goods and services provided by the Region as well as to facilitate the purchase of miscellaneous goods and services.

During 1998, five petty cash funds required increases totalling \$5,360. Three petty cash funds were closed and no new petty cash or change funds were established. The net result of these changes was an increase in the amount of petty cash and change funds by \$5,055 to \$78,555.

A review of the operations of all petty cash and change funds was made as at December 31, 1998. All custodians were contacted and have submitted completed certificates of the amount of cash and paid vouchers on hand at that date with the exception of two petty cash funds amounting to \$125.00 with Social Services which have now been closed. The certificates were checked with our accounting records and found in order. The imprest bank accounts have been reconciled as of December 31, 1998 and are in order.
