SUBJECT/OBJET 1997 ECONOMIC DEVELOPMENT GRANTS REPORT

BACKGROUND

On 26 October 94, Council approved the establishment of an Economic Development Grants Program (EDGP) to replace General Grants. 1997 is the third year the Program has run. The prime focus of the Program is to promote economic activity in Ottawa-Carleton. Non-profit organizations providing programs or initiatives with economic benefits within the Regional Municipality of Ottawa-Carleton (RMOC) are eligible.

TO BE LISTED ON CORPORATE SERVICES AND ECONOMIC DEVELOPMENT COMMITTEE AGENDA - 06 May 97 Paul Wilker attended the 28 Feb 97 Panel assessment meeting as an alternate for the Ottawa-Carleton Research Institute.

Budget

An Economic Development Grants budget of \$276,000 was approved by Council on 26 Feb 97. The 1996 budget was \$286,000.

ASSESSMENT PROCESS

Grant applications were received by 1 Oct 96 and reviewed by staff for initial eligibility criteria. The applications were distributed to all members at the first Panel Meeting on 28 Jan 97 accompanied by an Assessment Guideline Sheet (Annex A).

All grant requests were reviewed individually using the published criteria outlined in the Assessment Sheet; priorities were determined, and the funding was allocated.

FUNDING RECOMMENDATIONS

The Panel reviewed 33 applications requesting a total of \$562,440. Attached (Annex B) is a complete listing of requests and the final funding decisions.

RIGHT OF RECONSIDERATION

Following the assessment process, all applicants were notified of the final decisions. The notification package included a completed copy of the applicant's Assessment Guideline Sheet, a listing of all applications received and the Panel's financial decisions.

Applicants were advised in the notification letter of the Right of Reconsideration procedure. No responses were received.

MODIFICATIONS FOR 1998

The Allocations Panel reviewed the overall process to identify areas that would provide clearer direction to applicants and better facilitate the assessment process. In 1998 the Panel recommends that consideration be given at budget time to integrating funding for the Festival Network into Ottawa Tourism and Convention Authority's base budget through the Purchase of Service agreement. The Ottawa Tourism and Convention Authority and the Festival Network will be consulted when considering this item.

CONSULTATION

The notice of grant decisions has been distributed to all 1997 Economic Development applicants.
