TO URBANDALE CORPORATION**

DEPARTMENTAL RECOMMENDATION

That the Corporate Services and Economic Development Committee and Council approve reimbursement to Urbandale Corporation, Ottawa, for the construction of part of the Portobello Storm Sewer that drains Innes Road, in the amount of \$104,757.76.

BACKGROUND

The Portobello Boulevard storm sewer connects the drainage ditches on Innes Road to the Hydro Corridor and the storm water retention system for this area of Cumberland Township. It drains 3.83 hectares of the Innes Road right-of-way between Pinard Way and Provence Avenue in Cumberland Township.

Capital authority of \$250,000 has been allocated for a Regional contribution to area-wide drainage systems which include the effective storm drainage of Regional Roads undertaken in conjunction with area municipalities. The Township of Cumberland and Urbandale Corporation, the adjacent land developers, are contributing to the overall storm drainage in this watershed area.

This is part of the overall East Urban Community Master Drainage Plan and as such an environmental assessment was carried out by the Township of Cumberland.

DISCUSSION

Departmental staff have analyzed the existing storm sewers and various contribution proposals. In keeping with the Storm Water Policy, the Department recommends that the subject contribution be made which is based on the nominal limiting capacity for a 27" storm sewer.

The total construction cost of the Portobello storm sewer was \$463,931.24. The Region's share for the draining of Innes Road is \$87,220. Engineering costs and GST bring the total contribution to \$104,757.76 which is approximately 19% of the total.

CONSULTATION

No public consultation has taken place on this project as it is a Cumberland Township project.
