#### **DEPARTMENTAL RECOMMENDATIONS**

That the Corporate Services and Economic Development Committee recommend Council approve:

- 1. Submission of an application to the Canada-Ontario Infrastructure Works Programme for approval of Project 912-30718, Laurier Avenue Rehabilitation from Nicholas to Charlotte;
- 2. The enactment of a By-law approving the Laurier Avenue Rehabilitation (Annex A);
- 3. A pre-commitment to the 1997 Capital Budget for the above project in the amount of \$4,444,000 gross authority, \$1,397,000 net Regional requirement (Annex B) and the reallocation of surplus Federal/Provincial subsidy in the amount of \$3,047,333 from various COIW projects (Annex C), subject to approval of the Laurier Avenue project by the Canada-Ontario Infrastructure Works Programme;
- 4. The reallocation of surplus Federal/Provincial subsidy in the amount of \$530,000 from various COIW projects to Project 912-30667, St. Joseph Boulevard Reconstruction (Annex C).

#### BACKGROUND

On 24 January 1994 the Region received notification of its funding allocation under the COIW programme for projects with eligible costs totalling \$78.352 Million. Costs are to be shared equally among the Federal Government, the Province of Ontario and the Regional Municipality of Ottawa-Carleton. Project authorities and financing for nineteen projects were approved by Council on 22 June 1994. Subsequently, the Carp Airport project was approved 28 September 1994, and existing COIW funding was reallocated to the project within the overall allocation.

#### DISCUSSION

#### Laurier Avenue

The rehabilitation of Laurier Avenue is currently shown in the 1996 Capital Budget (reference page 83) and scheduled for construction in 2000 and 2001. This project is a very high priority for RMOC road and watermain reconstruction, and for the City of Ottawa's sewer requirements. The budgets for water and sewer needs are currently on hold, pending approval of the road rehabilitation project. As indicated on the proposed 1997 Capital Budget sheet (Annex B) for this project, construction would be advanced to 1997 commencing with Phase 1 from Nelson to Charlotte.

Under the current COIW agreement, construction of the approved projects must be complete on or before March 31,1997. In spring 1995 the Federal Government declared their intent to extend the programme by 2 years. Formal notice has not been received to date of the approval of this new agreement between the Federal Government and the Province of Ontario. However, the intent is to submit an application for approval of the Laurier Avenue project in advance of the new COIWP agreement in anticipation of having the paperwork in place when the agreement is approved so that construction of Laurier Avenue will not be unnecessarily delayed.

#### St. Joseph Boulevard

On 27 September 1995, Council approved a transfer of funds in the amount of \$525,000 to the St. Joseph Boulevard project (912-30667) in order to stabilize slopes on the north side of the road resulting in an increase to eligible costs. Review of the unfunded eligible COIW costs in this project indicate additional Federal/Provincial funding of \$530,000 can be allocated to offset these and other eligible costs.

#### CONSULTATION

Public consultation takes place with each of the projects as required on an individual project basis. Public consultation is not required to establish project authorities for the COIW programme.

#### FINANCIAL IMPLICATIONS

Annex C indicates an overall surplus of COIW funding of \$3,047,333 (Federal/Provincial share) anticipated as a result of savings or scope reductions in various projects within the approved COIW programme. It is proposed that these funds be reallocated to the Laurier Avenue project.

The advancement of this project will result in a total project authority of \$5,000,000, \$556,000 of which is currently approved, and \$4,444,000 pre-committed to the 1997 Capital Budget. The combined Provincial and Federal COIW funding of \$3,047,333, as well as \$189,000 of MTO Base funding previously applied for design of the project results in a net project requirement to the Region of \$1,764,000. (Annex B)

Also, as indicated in Annex C, the reconstruction of St Joseph has an increase of eligible costs in the amount of \$795,000 due to the additional works. The reallocation of existing Federal/Provincial subsidy results in a reduction of \$530,000 to the net Regional requirement.

#### FINANCE DEPARTMENT COMMENT

The reduced capital spending requirements of \$5,366, 000 on the following projects will create \$3,577,333 of surplus Federal/Provincial COIW subsidy along with reducing the Regional financing requirement by \$1,788,667.

Debenture financing in the Region Wide Fund will be reduced by \$967,667. Regional financing for Water and Sewer projects will be reduced by \$618,667 and \$202,333 respectively. These funds will be returned to the Water and Sewer Capital Reserve Funds.

The report recommends that \$530,000 of the surplus subsidy be used to fund eligible costs in the St. Joseph Boulevard Reconstruction project. This surplus of \$530,000 will be returned to the Transportation component of the RDC Reserve Fund.

The report also recommends advancing the Laurier Avenue Rehabilitation project from 2000 to 1997. This will require additional spending authority in 1997 of \$4,444,000. The remaining surplus COIW subsidy of \$3,047,333 (\$3,577,333 - \$530,000) is proposed to be allocated to this project. The net Regional financing requirement of \$1,396,667 is proposed to be funded from the Region Wide Capital Reserve Fund.

The allocation of the surplus subsidy to Laurier Avenue and St. Joseph Blvd. is subject to approval by the COIW Management Board. Approval of the additional project requirements represents a precommitment of the 1997 Capital Budget and is subject to Council approval.
