DEPARTMENT RECOMMENDATION

BACKGROUND

The Ministry of Health requires that audited financial statements and settlement forms be submitted by the Health Department in order that the final determination of allowable costs and funding may be determined for the fiscal year in question. The Ministry requires that these settlements be approved by Regional Council.

Attached as Annex A is the calculation of allowable costs for the Healthy Babies/Healthy Children Program from its inception in November 1997 to March 31 1999.

Annex B is the March 31, 1999 calculation of allowable costs for the AIDS hotline program.

Annex C is the calculation of allowable costs for the PHRED program from January 1 1998 to March 31 1999.

Annex D is the March 31, 1999 calculation of allowable costs for the AIDS grant received.

No public consultation is necessary. Information was gathered according to financial reporting requirements and verified by external auditors.

FINANCIAL STATEMENT

The expenditures for the cost shared programs have been included in the audited financial statements of the Region. The balance of the programs are 100% funded by the Ministry of Health.
