WASTEWATER TREATMENT FACILITY SEWAGE HAULING CONTRACT 98-201

DEPARTMENTAL RECOMMENDATION

That the Corporate Services and Economic Development Committee and Council approve the award of Contract 98-201, Munster Hamlet Wastewater Treatment Facility Sewage Hauling to Vanson Construction Limited, Gloucester, for a total contract provision of \$643,819.

DISCUSSION

The existing Munster Hamlet wastewater treatment facility consists of lagoons and spray irrigation. The system is undersized for the flows that must be treated and as a consequence, the excess volume of wastewater must be transported by tanker trucks to the R.O. Pickard Environmental Centre for processing. It is expected that up to 65,000 m³ of wastewater may have to be hauled and that the operation will be completed by March 1999.

Tenders for Contract 98-201 (excluding G.S.T.) were received from the following companies:

Vanson Construction Ltd., Gloucester \$547,000 Sewer-Matic Environmental Services Inc., Gloucester 687,500

Departmental Estimate (excluding G.S.T.) 686,000

Based on a review of the tender documents, the Department recommends acceptance of the tender from the low bidder, Vanson Construction Ltd. The requested contract authority of \$643,819 includes a contingency allowance of \$54,700 to allow for contract variations due to unforeseen conditions, plus an allowance of \$42,119 for G.S.T. It is noted that the tender is below the detailed estimate prepared immediately prior to tender. In the spring, staff had reported to Council the conceptual cost for environmental mitigation, including hauling of wastewater at Munster Hamlet, to be approximately \$500,000.

CONSULTATION

There has been extensive public consultation as part of the Class Environmental Assessment process for the upgrading of Munster Hamlet Wastewater Treatment Facility, and this issue has been identified in that process. Managing the excess wastewater in Munster Hamlet in a sound environmental manner is consistent with the concerns expressed by the community during the Class Environmental Assessment public consultation process.

EXPENDITURE JUSTIFICATION

This work is required to ensure the effective operation of the Munster Hamlet wastewater treatment facility and minimize impacts on the surrounding environment and the community.
