### **DEPARTMENTAL RECOMMENDATION**

That the Corporate Services and Economic Development Committee and Council approve the purchase of computer equipment as an upgrade to existing architecture from Intergraph Canada Limited, Mississauga, for a total contract provision of \$399,050.

#### BACKGROUND

As part of the corporate Geographically Referenced Information System (GRIS), the Automated Mapping/Computer Aided Design and Drafting (AM/CADD) requirements of the Corporation are met by the hardware and software products provided by Intergraph Canada Limited. A contract was signed with Intergraph in April 1991 and an initial purchase was made. This purchase, to replace some of the originally purchased equipment, will become part of and subject to, the terms and conditions of the "AM/CADD Acquisition Agreement" between Intergraph Canada Limited and the Corporation.

The cost of this equipment will be recovered, over time, from the Capital projects for which it is used. The rates used will be the same as those that the Corporation permits outside consultants to charge for the use of similar equipment (from \$20 to \$40 per hour depending on the purpose).

The equipment currently used by the Department generated \$245,912 in revenues during 1993, \$501,100 during 1994 and \$550,500 in 1995.

#### DISCUSSION

It is necessary to purchase the replacement equipment at this time to ensure that the necessary tools are available to continue with the ongoing design of infrastructure facilities for the Department. The equipment being replaced utilizes an operating system (CLIX) that the vendor no longer actively supports. The most recent version of the software used for CADD activities does not run under the existing operating system therefore necessitating its replacement.

#### **EXPENDITURE JUSTIFICATION**

The equipment being replaced carries associated annual maintenance costs of approximately \$81,000. The annual maintenance costs of the replacement equipment is approximately \$31,000, representing an annual savings of \$50,000. Some of the equipment being replaced will also be integrated into the normal office automation environment of the Department and this will result in a one time savings of \$18,000 to the Corporation in relation to the corporate 386 microcomputer replacement program. Intergraph Canada is also offering a "trade-in" value of \$50,000 for the return of the existing equipment that cannot be reused within the Department. Other savings will also be realized as the Corporation moves towards the NT operating system as some of the equipment being purchased will also be integrated into the general office environment, thus reducing or eliminating future hardware purchases.

Based solely upon the reduced maintenance costs and the one time savings to the Corporation the cost avoidance of this equipment equates to \$218,000 over three years. According to trends over the past three years, this equipment will result in recoveries of approximately \$500,000 annually.
