DEPARTMENTAL RECOMMENDATION

That the Planning and Environment Committee recommend that Council lift Deferral No. 19 to the City of Ottawa Comprehensive Official Plan, and approve the relevant text as set out on the Approval Page attached as Annex I.

DISCUSSION

When Council approved the bulk of the City of Ottawa's Comprehensive Official Plan in 1994, one of the items it deferred from approval was the following policy in the "Key Principles" for the Ottawa East Neighbourhood Plan:

"To limit expansion of the Queensway, i.e., that the proposed extensions of Catherine and Isabella Streets east of the Canal, together with any further structures over the Rideau Canal in this location, be deleted from the Regional Plan."

In 1994, the Regional Official Plan showed what were known as the Queensway service lanes, part of which extended from Catherine Street across the Canal to Nicholas Street, and extended Isabella to connect to Lees Avenue.

The 1997 version of the Regional Official Plan no longer contains the Queensway service lanes, and the City of Ottawa has written to ask that the deferral of the above quoted policy be lifted and that the policy be approved.

This request conforms to the Regional Official Plan and should be approved.

CONSULTATION

As this involves approving a deferred policy which was itself the subject of public consultation as part of the Official Plan process, no further consultation is required.
