DEPARTMENTAL RECOMMENDATION

That the Corporate Services and Economic Development Committee recommend to Council that \$38,000 in costs be incurred by the Legal Department to defend the position of Regional Council at the upcoming Ontario Municipal Board hearing on the Regional Official Plan, Policy 4.7.3 and Kanata Official Plan Amendments Nos. 45, 46 and 51.

BACKGROUND

The Ontario Municipal Board has scheduled a 6.5 week hearing, to commence 22 September 1999 to consider Regional Official Plan policy 4.7.3 and amendments nos. 45, 46 and 51 to the Kanata Official Plan. The Regional Official Plan policy 4.7.3 and the Kanata Official Plan Amendments broadly concern the commercial policies for Kanata's Regional shopping centre site and the business parks and industrial areas in the City of Kanata. Regional Council has already established its position on Amendment No. 45 (Planning and Environment Committee Report 27, Item 5) and Amendment No. 51 (Planning and Environment Committee Report 37, Item 3) at its meetings of 10 March 1999 and 14 July 1999 respectively. Regional Council will be considering its position on Amendment No. 46 at its meeting of 8 September 1999.

EXPENDITURE JUSTIFICATION

In order to present the Region's case both marketing and planning evidence will be required. To provide marketing evidence, the Region has retained Scott Morgan. The planning evidence will be given by Joseph Phelan, Senior Project Manager, Land Use and by Andrew Hope, formerly a Senior Project Manager in the Development Approvals Division. Mr. Phelan will provide the

factual background and policy analysis of the Regional Official Plan policies. Mr. Hope has been intimately involved in the local official plan matters in his role in Development Approvals since the first consideration by Kanata of an amendment to revise the commercial policies was brought forward in October, 1994.

The commercial policies in Kanata have been the subject of numerous pre-hearings before the Ontario Municipal Board and two full mediation sessions. It had been hoped that through the extraordinary interventions by the Board that a full hearing could be avoided or at least the length of the hearing could be shortened. Unfortunately, such has proven not to be the case.

As outlined in Planning and Environment Committee Report 27, Item 5 on Kanata Official Plan Amendment No. 45, neither the 1999 Legal or Planning and Development Approvals Department budgets contained funding for the evidence required to defend Council's position. An amount of \$40,000 was included within the 1999 Legal Department budget for the preparation of Mr. Morgan's initial report, submitted to the Region in February, 1999, which amount has been expended. The estimated additional cost of the hearing, including disbursements for travel and accommodation, is:

Planning Evidence	- \$ 8,000
Marketing Evidence	- \$28,000
Supplies and Printing	- \$ 2,000
Total	- \$38,000
