The Council of the Regional Municipality of Ottawa-Carleton met at Haydon Hall, Regional Headquarters, 111 Lisgar Street, Ottawa on Wednesday, 23 April at 1:30 p.m.

The meeting was called to order at 1:33 p.m. and opened in prayer.

The Regional Chair, Peter D. Clark, presided.

CONFIRMATION OF MINUTES

The minutes of the Regular Council meeting of 9 April 1997 were confirmed.

*COMMUNICATIONS

1. Bryan Wilfert, President, Federation of Canadian Municipalities (FCM) urging Council to adopt a resolution that calls for deposit/return regulations on all beverage containers sold in the Province, for packaging stewardship programs. FCM has actively encouraged industry to voluntarily achieve waste diversion targets for packaging and feel that if targets are not met legislation will be required.
2. Eldred King, Vice-Chairman, GO Transit, endorsing OC Transit Commissions resolution regarding Exemption of Employee Transit passes from taxation.
3. Village of Rockcliffe Park, forwarding their resolution which opposes the closing of the Montfort Hospital and supporting the city of Vanier in this regard.
4. United Counties of Stormont, Dundas and Glengarry responding to Council's resolution on Provincial Highway Transfers, and advising that their Council has endorsed the RMOC recommendations in this regard.
5. United Counties of Stormont, Dundas and Glengarry responding to Council's resolution on bilingual stop signs in Ontario and advising that it was filed without any further action taken.
6. Town of Jaffray Melick, forwarding their resolution regarding downloading of Provincial Highways, which recommends that they refuse to accept responsibility for highways unilaterally downloaded by the province and are asking Council to endorse their resolution.
7. Judy MacDonald, Ontario Water Works Association advising Council of Drinking Water Awareness Week from May 4-10, 1997, with the purpose of promoting efficient use of water resources and a better understanding of the quality of drinking water. They are encouraging the RMOC be a part of the activities in a variety of ways.
8. Carp Agricultural Society thanking Council for the grant that they received, which will help stage the Ontario Farriers' Competition at their 134th Annual fair.

9. Organization of Small Urban Municipalities 44th Annual Conference will be held from April 30 to May 2, 1997 in Stratford. An information package was attached for additional information and itinerary.
10. Federation of Canadian Municipalities (FCM) advising that they intend to make candidates for the next Federal election, more aware of municipal government issues and concerns, and seek their commitment to address these issues. Accordingly FCM is seeking the submission of specific issues, such as downloading of services to municipalities by Federal or provincial governments.
11. Canadian Soft Drink Association, setting out the reasons why their association opposes a deposit-based solution such as that supported by the Ontario Beer Industry and their commitment to provide Blue Box solutions to handle waste and recycling.
12. City of Kanata, responding to the RMOC's proposal to realign due dates for remittance of the levy by area municipalities. The city objects to the Region's proposals to change tax levy due dates and that this should be looked at in conjunction with other impacts facing municipalities, regarding provincial downloading of services.

13. The Honourable Al Leach, Minister of Municipal Affairs and Housing, acknowledging Council's letter regarding restructuring in Ottawa-Carleton. He feels that restructuring should be a locally driven initiative, including panel selection and time-line dates. He plans to extend restructuring authority to regional municipalities as well as counties and the north.

1. PRIVATE SIGNS ON REGIONAL ROADS - HIGHWAY SIGNS BY-LAW

COMMITTEE RECOMMENDATIONS AS AMENDED

1. The Highway Signs By-law;
2. The deletion of Section 2.2.4 of the Regional Regulatory Code;
3. Amendments to Parts 2.5 and 2.10 of the Regional Regulatory Code to exempt the placement of signs pursuant to the Highway Signs By-law;
4. That as staff resources permit, unauthorized signs be removed from Regional roads and that staff respond as required on a complaint basis, except where a sign is an obvious safety hazard;
5. That permit fees not be charged, except for banners;
6. That a processing fee of \$34.00 per application be charged to cover the administrative cost of processing an application to place a banner on or over a Regional road;
7. That the area municipalities be requested to adopt the Highway Signs By-law to regulate signs within their jurisdictions which will establish uniform sign regulations;
8. That staff liaise with the area municipalities to develop standards allowing additional signs on the road allowance, by permit;

- 9. That sandwich board/A-frame signs be allowed in a similar fashion to that of the City of Ottawa in the City of Ottawa only and that the by-law be amended accordingly, and;**
- 10. That there be allowed one poster per block face per poster subject within the boundaries of the Ottawa River to the North, the Rideau River (Billings Bridge) to the south and east from the Rideau River to Preston Street.**

WHEREAS the Minister of Municipal Affairs and Housing in a letter to Regional Chair Peter Clark is encouraging “all parties to persevere and to complete the development of a locally designed process”; and

WHEREAS the broad approval of the McGarry motion has shown that a locally designed process and a local solution to the current governance problem is possible; and

WHEREAS this issue will be hotly debated during the 1997 municipal election and these debates will be extremely valuable in understanding the issues and concerns of residents of this region; and

WHEREAS the next and most difficult step in the restructuring debate is the establishment and composition of a citizens panel; and

WHEREAS to be successful in this endeavour we must recognize the legitimate concerns of all of the region’s residents and we must ensure that the panel can recognize, understand and resolve those concerns;

THEREFORE BE IT RESOLVED that the Ottawa-Carleton Citizen’s Panel on local government reform be comprised of 16 members plus a Panel Chairperson; and

FURTHER BE IT RESOLVED that appointment to the 16 member panel be made on the following basis:

- **8 members appointed by Regional Council**
- **4 members appointed by the Council of the City of Ottawa**
- **4 members appointed by the remaining area municipalities**

FURTHER BE IT RESOLVED that a committee comprised of the Regional Chair, the Mayor of the City of Ottawa and a representative of the Ottawa-Carleton Mayors forum appoint the Panel Chairperson; and

FURTHER BE IT RESOLVED that the 8 members of the citizens panel to be appointed by Regional Council reflect the linguistic duality and the geographic diversity of The Region of Ottawa-Carleton; and

FURTHER BE IT RESOLVED that in addition to following responsibilities:

- **To hear submissions from politicians and taxpayers of Ottawa-Carleton.**
- **To identify guiding principles.**
- **To investigate all models of governance.**
- **To hold public hearings across the region of Ottawa-Carleton.**
- **To undertake research on different political and administrative structures/models.**

that the panel be tasked with developing a comprehensive terms of reference and timeframe and that the terms of reference and timeframe be adopted by the panel before July 30, 1997; and

FURTHER BE IT RESOLVED that this motion be adopted by Regional Council subject to it being endorsed by a majority of area municipal councils representing a majority of the population and forwarded to the Minister of Municipal Affairs and Housing for his information and circulated to all area municipalities for endorsement.
