#### **BACKGROUND**

Since 1993, Regional Council through the Health Department has contracted with the Ontario Ministry of Health to operate the Program Training and Consultation Centre of the Ontario Tobacco Strategy in partnership with the University of Waterloo, Centre for Applied Health Research and RBJ Health Management Associates. The Centre has a mandate to provide training and consultation in tobacco use prevention to communities across Ontario. A six month workplan and budget of \$150,000 for the operation of the Centre has been approved by the Ministry for the period April 1, 1998 to September 30,

1998 (see Annex A) as an extension of the existing contract between the Ministry of Health and the RMOC.

Key roles of RBJ Health Management Associates include;

- development of specific program resources
- delivery of training and consultation services
- conduct planning and evaluation for the centre

Details are specified in the approved workplan.

# Key roles of CAHR include;

- advise PTCC Management Committee, Coalition of Ontario Agencies for School Health and other committees as appropriate
- develop a resource box of tools and resources to support minimal contact interventions for smoking cessation
- coordinate a one-hour teleconference on an emerging tobacco control issue
- conduct on-site consultations

Details are specified in the approved workplan.

# PUBLIC CONSULTATION

The PTCC has three key user groups: Ontario public health units, local Councils on Smoking and Health across Ontario, and all Ontario community health centres. All services provided by the PTCC have been evaluated by users and other participants as very good to excellent.

# FINANCIAL IMPLICATIONS

This is a 100% Ministry of Health funded program. Funds will be provided for in 792-55721.
