**DEPARTMENTAL RECOMENDATIONS**

**That the Corporate Services and Economic Development Committee and Council approve:**

- 1. The appointment of McCormick Rankin Corporation, Ottawa, for Contract No. ETL00-5042, to carry out the detailed design and contract document preparation for the Woodroffe Avenue and Fallowfield Intersection, for a total contract provision of \$355,963;**
- 2. The transfer of funds in the amount of \$100,000 from the project, March Road (Solandt to Klondike) (Order No. 900066) to Woodroffe Avenue/Fallowfield Road Intersection (Order No. 900530).**

**BACKGROUND**

The current intersection of Woodroffe Avenue and Fallowfield Road is generally constructed with a rural cross-section and with the current high traffic volumes, is operating at level 'F'. The proximity of the railway crossing on Woodroffe Avenue to the intersection has created a serious safety concern as long traffic queues form and vehicles have been trapped on the railway tracks. Temporary traffic signal arrangements have been implemented to minimize the impact of this situation.

The Environmental Study for the reconstruction of Fallowfield Road from Highway 416 to Woodroffe Avenue was completed in October 1997. Currently, the Environmental Study for Woodroffe Avenue from Fallowfield Road to Strandherd Road is underway. This study should be complete by the end of this year.

## DISCUSSION

The area in the vicinity of this intersection is subject to tremendous growth at this time. The increase in residential, commercial and industrial development (i.e. JDS Uniphase) will place even further demand on the intersection which is already operating at capacity. The Terms of Reference define the project limits as Fallowfield Road from the railway crossing to 600 m. east of Woodroffe Avenue and Woodroffe Avenue from the railway crossing to a point 300 m. south of Longfields Drive.

The selection process for this Consultant was carried out with the Supply Management Division. Ten Consultants responded to the Department's Request for Qualifications (RFQ). From the responses to the RFQ, the Department short-listed three firms familiar with this type of design work using several evaluation criteria and requested these firms to submit a response to the Department's Request for Proposal (RFP). They were: Delcan Corporation, McCormick Rankin Corporation and Stantec Consultants Limited. McCormick Rankin submitted the proposal providing the best value to the Region of Ottawa-Carleton by having achieved the highest score based on the evaluation criteria (Resources and Experience of the Firm, Experience, Qualifications and Availability of Team Members, Understanding of Objectives, Quality of Approach and Methodology, Schedule, Proposed Work Plan and Level of Effort, and Financial).

McCormick Rankin Corporation's financial proposal included with the RFP indicated an estimated fee of \$302,432.25. The addition of a contingency allowance of \$30,243.23 and \$23,287.28 for GST brings the total contract provision to \$355,962.76.

Recognizing the lack of capacity, the imminent growth and the existing safety concern at the railway crossing on Woodroffe Avenue, the City of Nepean Council has agreed to make a contribution towards the final design work for costs that exceed \$250,000 up to a total project upset limit of \$500,000 (see Annex 'A'). This contribution is also subject to the completion of the design work and contract documents by March 2001.

## CONSULTATION

The public consultation process is not applicable.

## EXPENDITURE JUSTIFICATION

Regional Council, on 22 December 1999, passed a Motion indicating that \$250,000 was to be allocated for the design of the Woodroffe Avenue and Fallowfield Road intersection due to the poor operational level, the strong growth in the area and the Nepean Council approved contribution towards the project.
