DEPARTMENTAL RECOMMENDATION

That the Transit Services Committee approve the appointment of seven interim members to the Regional Transit Advisory Committee until November 2000 as recommended in this report.

BACKGROUND

The Regional Transit Advisory Committee membership has now been depleted by the resignation of seven members, and one position was never filled. There are currently eight vacancies in the Far West, West, Southwest, West Central, Central, Southeast and Far East areas.

In response to this situation and, in view of the changes in local government which will be occurring in the coming year, an advertisement was placed for interim members to fill these positions until November 2000.

In December 1999, applications were invited through an advertisement carried in the Regional Page in the Ottawa Citizen, The Ottawa Sun and Le Droit (Exhibit 1).

DISCUSSION AND RECOMMENDATION

In all, eight applications were received. One application was received for each geographic area where there was a vacancy and two applications were received for the West Central area. Two vacancies exist in the Central area but only one application was received.

The only area where a contention exists is for the West Central area. It is recommended that this position be given to Mr. Lewis Levy who has been attending the meetings as an un-official member for the past year, and that all other applicants be appointed to the Regional Transit Advisory Committee until November 2000.
