SUBJECT/OBJET **LYON STREET TRAFFIC CALMING PILOT STUDY**

REPORT RECOMMENDATION AS AMENDED

That Transportation Committee recommend Council approve the construction of calming measures for Lyon Street, identified in Annex A, including the addition of a speed hump between Somerset Street and Maclaren Street as part of the Lyon Street Traffic Calming Pilot Study.

BACKGROUND

At its meeting on 21 July 1998, the Transportation Committee approved the attached report, as amended, dated 29 June 1998 from the Environment and Transportation Department. An extract of Draft Minute immediately follows the staff report.

The Committee agreed to commence the advertising of this item immediately and to schedule a public hearing on 2 September 1998. Accordingly, the project was advertised in the three daily papers on the following dates: August 1, 2, 8, 9, 15, 16, 22 and 23, 1998. A variety of comments have been received as a result of this advertising, and these are issued under separate cover.

SUBJECT/OBJET **LYON STREET TRAFFIC CALMING PILOT STUDY**

DEPARTMENTAL RECOMMENDATIONS

That Transportation Committee recommend Council approve:

- 1. the construction of calming measures for Lyon Street, identified in Annex A, and;**
- 2. the initiation of the public hearing process as required by Sections 297 and 300 of the Municipal Act (Ontario).**

BACKGROUND

Regional Council, on 8 April 1998, received the consultant's study report for the Centretown Traffic Calming Study and approved, as a pilot project, the construction of the following traffic calming measures for Lyon Street:

- a. speed humps on Lyon Street between
 - Arlington Avenue and Flora Street;
 - Flora Street and McLeod Street;
 - McLeod Street and Gladstone Avenue;
 - Florence Street and James Street;

- James Street and Gilmour Street; and
 - Gilmour Street and MacLaren Street.
- b. raised intersection at Lyon Street at Gladstone Avenue; and
- c. intersection narrowings on the north side of McLeod Street at Lyon Street.

The purpose of these traffic calming measures is to reduce speed on Lyon Street. This would result in a safer roadway for all users including pedestrians and cyclists.

A meeting with staff and the Emergency Services will be held in the near future. Their response to these modifications will be available for the public hearing.

PUBLIC CONSULTATION

Extensive public consultation for this project was carried out during the study phase of this report. Flyers will be distributed to those land owners immediately affected by these modifications, detailing the exact locations of the proposed measures.

The opportunity for further public input will be provided via the public hearing process.

REGIONAL CYCLING ADVISORY GROUP

These measures have been circulated with the RCAG representative and comments/input from that group, if any, will be provided through the public hearing process.

COST ESTIMATE

The following cost estimate is provided for the information of the Transportation Committee and Council.



FINANCIAL IMPLICATIONS




REGIONAL ROAD TRAFFIC CALMING PILOT PROJECT
