**Re: Highway 31 - Road Condition**

The purpose of this letter is to request your immediate attention to the timing of the rehabilitation of Highway 31.

I understand that this roadway was included in your 1997 Asphalt Overlay Program as a supplemental section. The reason for this, as I understand it, was because your staff was unsure as to when it would be transferred. Otherwise, it would have been in the regular schedule (i.e. not supplemental).

I would now ask that you reconsider the priority of this section of roadway in your 1997 Asphalt Overlay Program now that the ownership of the roadway has been confirmed.

Our staff have previously requested the reconsideration of this priority and, being quite familiar with this section of roadway, I can attest to the urgency of these requests.
