SUBJECT/OBJET **STREET VENDING PROHIBITION - CITY OF KANATA**

DEPARTMENTAL RECOMMENDATION

That the Transportation Committee recommend Council approve the amendments to Schedule B of Part 2.11 of the Regional Regulatory Code, as described in the body of this report.

INTRODUCTION

The City of Kanata has requested the Department to amend the Regional Regulatory Code to prohibit street vending on Regional roads within its boundaries. The correspondence is attached as Annex A.

DISCUSSION

Part 2.11 (the Street Vendors By-law) of the Regional Regulatory Code regulates street vending on Regional roads. To capsulize, street vending is prohibited, except for a farmer selling produce of his/her own growing, a person selling goods, merchandise, services or soliciting funds on behalf of an organization for charitable purposes, or within an area municipality that has agreed to regulate, control and accept liability for vending in its jurisdiction. To date only the Cities of Ottawa and Gloucester have requested the exemption.

Notwithstanding the above noted prohibition exceptions, there is a provision in the by-law allowing the Region to prohibit vending entirely on certain roads, listed in a schedule. The schedule currently lists all the Regional roads within the City of Nepean, and some roads in the central core of the City of Ottawa.

Therefore, the City of Kanata's request is not without precedent. City of Kanata staff advise that the total prohibition is being requested because (a) vending is prohibited on its local roads and this would make the regulations uniform within its jurisdiction, and (b) they have been receiving complaints about motorists stopping for and leaving roadside vendors creating a safety hazard.

To comply with the request would require an amendment to the Regional Regulatory Code.

SCHEDULE AMENDMENTS

It is recommended that Schedule B to Part 2.11 of the Regional Regulatory Code be amended by adding the following Regional roads located within the limits of the City of Kanata.

Additionally, some of the existing entries in Schedule B to Part 2.11 are now either redundant or have to be amended to reflect changes in the Regional Road System. It is recommended that the Schedule be amended by deleting the following roads:

PUBLIC CONSULTATION

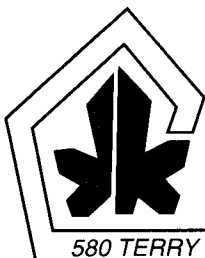
No public consultation was conducted because this is a request made by the City of Kanata to provide consistent vending regulations within its jurisdiction in response to concerns expressed by residents.
