Susan Jones, General Manager, Emergency and Protective Services and Linda Anderson, Chief By-Law Officer gave a summary and brief PowerPoint presentation. A copy of the presentation is held on file with the City Clerk's office.

Some delegations provided written speaking notes which are held on file with the City Clerk's office. All delegations were in favour of the staff report and are hoping that it may go further. Many residents in Sandy Hill stated that the St. Patrick's Day party which occurred was of great concern and actions need to be taken with the University of Ottawa. They feel that higher fines from the beginning will be a good deterrent.

MOTION No. CPS 15/2

Moved by Councillor M. Fleury

WHEREAS noise is an increasingly prevalent community concern in neighbourhoods with high density; and,

WHEREAS By-law Enforcement Officers are on duty until 2:00 a.m. daily, year-round; and,

WHEREAS noise disturbances often occur after 2:00 a.m., after which time they become the responsibility of the Ottawa Police Service, for which noise is not a priority; and,

WHEREAS By-law and Regulatory Services has undertaken a pilot program in which a small complement of enforcement staff is on duty until 3:30 a.m. on Thursdays, Fridays and Saturdays;

THEREFORE BE IT RESOLVED THAT staff report back on the efficacy of the pilot and the feasibility of implementing it on a permanent basis, if appropriate, along with any other initiatives to improve response.

WHEREAS noise is an increasingly prevalent community concern in neighbourhoods with high density; and

WHEREAS property owners are not currently made aware of violations of the Noise By-law committed by their tenants; and,

WHEREAS notifying property owners of their tenants' behaviour would make them aware of the impact of the behaviour on the surrounding community, as well as provide information concerning problematic units;

THEREFORE BE IT RESOLVED THAT By-law and Regulatory Services be directed to, in consultation with Legal Services, review the potential for the implementation of a system which would notify property owners of violations by their tenants of the Noise By-law (2004-253) and the Property Standards By-law (2005-207)

WHEREAS there are concerns about inadequate monetary penalties for noise offences; and,

WHEREAS the Noise By-law (2004-253) contains an "Offence and Penalties" section that was enacted under previous provisions of the *Municipal Act, 2001*; and,

WHEREAS it would appear that the existing fines do not constitute an actual deterrent with respect to future breaches of the by-law; and,

WHEREAS the *Municipal Act, 2001* has since been amended to provide authority for more extensive penalties;

THEREFORE BE IT RESOLVED THAT the Noise By-law be further amended to incorporate the newer penalty provisions of the *Municipal Act, 2001*, and staff be directed to review the charges and fines related to all Provincial Offence Notices once per term of Council.

MOTION No. CPS 15/5

WHEREAS the City of Ottawa is home to four post-secondary institutions with a sizable student population living on and off-campus;

AND WHEREAS the City of Ottawa currently does not have a dedicated City staff resource to work on the many issues in which the City of Ottawa interacts with post-secondary institutions, such as off-campus housing, UPASS, and other City initiatives and projects that post-secondary institutions have a stakehold in;

THEREFORE BE IT RESOLVED THAT the City of Ottawa identify a City of Ottawa employee to facilitate collaboration and discussion with the University of Ottawa, Carleton University, Saint-Paul University and Cité Collégiale on an assortment of issues related to the interactions between post-secondary institutions, the City of Ottawa and the community.

as outlined in the Housing and Poverty Reduction Investment Plan (ACS20011-COS-CSS-0005) approved by Council May 11, 2011, on a per unit basis to all eligible social housing providers with projects currently under the administration of the City of Ottawa as the Service Manager; and

2) For 2013 and beyond, an amendment to the Delegation of Authority By-law, By-law Number 2012-109, to delegate authority to the Administrator of Housing Services to allocate the funding envelope for Social Housing Repair as referenced in report ACS20011-COS-Css-0005 to prescribed Housing Providers currently in receipt of annualized capital subsidy contributions as outlined in legislation and operating agreements, in a manner supported by data indentified in the 2012 Capital Building Program as outlined in this report and the current level of capital subsidy contributions received from the Service Manager.

- That the Ottawa Arts Court Foundation be granted 60 days to explore a merger with the Council for the Arts in Ottawa, and that Cultural Services assess the viability of the merger and report back at the end of August 2012 on the results; and
- 2. That the Ottawa Arts Court Foundation receive three final funding installments of \$15,252 on May 24, June 24 and July 24, 2012 to be used exclusively to maintain summer theatre operations serving the arts community and to sustain the organization.

Chair Taylor gave a brief summary of the staff report and stated that Dan Chenier, General Manager, Parks, Recreation and Cultural Services was present to answer any questions if necessary.

The Committee heard from the following delegations:

- Susan Annis, Chair, Ottawa Arts Court Foundation, stated that the idea of merging the Ottawa Arts Court Foundation and the Council for the Arts in Ottawa was not a new one and they are looking forward to working with the Council towards a possible working solution to their present dilemma.
- Peter Honeywell, Executive Director, Council for the Arts in Ottawa, commented that his Board had met and agreed to the 60 day review period. He will take the lead on behalf of the Council and is looking forward to working with the Foundation without putting the Council in financial risk or debt.

Following the presentation and delegations staff responded to members' questions.

The report recommendation was then put to Committee and CARRIED, as presented.
