Background:

Board policy B.23 relates to Board participation in library-related conference, meetings and events. It states in part: "The experience of participating in conferences, seminars or workshops is a valuable opportunity for Library Board Trustees, and one that benefits the trustee and the Library." Library Board members are encouraged to attend relevant library conferences as a means to promote Board development and excellence.

About the Conference:

The CLA Conference held once a year is a national professional and trustee development event offering six in-depth pre-conference sessions, six organized tours, and over seventy concurrent sessions on a wide variety of issues and the CLA Annual General Meeting. CLA will provide opportunities to learn new ideas, share success stories, hear best practices and meet colleagues from across the country. This year, the event is being held from May 30 – June 2, 2012 at the new Ottawa Convention Centre. Anticipated conference attendance is 1,000 to 1,200. This year, the conference is designed to take advantage of the Ottawa location to provide opportunities for members to interact directly with government officials and impact Public Affairs, and Members of Parliament in their offices.
