BACKGROUND

This report provides a summary of the 2011 regulatory compliance undertakings of the various operating groups that are responsible for the delivery of the wastewater services, and it demonstrates that the Wastewater Services Branch was in full compliance with environmental legislation for the year 2011.

The Wastewater Services Branch must adhere to complex and extensive Provincial and Federal environmental regulations in the administration of its various operations. The Branch evaluates annually how well it meets these regulatory requirements. Two reports were used to evaluate the Wastewater Services environmental compliance: a third-party Regulatory Compliance Report, submitted by Stantec Consulting Inc., attached as Document 1, and the Ministry of the Environment (MOE) Communal Sewage Inspection Report, attached as Document 2.

DISCUSSION

MOE Communal Sewage Inspection Report

The MOE carries an inspection of the Robert O. Pickard and its collection system on an annual basis. The inspection includes a review of operating data and a visit. The objective of the inspection is to perform a detailed assessment of compliance with the terms and conditions of the numerous applicable Environmental Compliance Approvals (formerly called Certificates of Approvals) and conformance with MOE policies and procedures.

The effluent quality is reviewed and compared with quality objectives and limits. The capacity of the plant is also assessed and compared with incoming flows. The collection system overflows and by-passes are reviewed and evaluated. The MOE Inspection Report:

- 1) Reviews the previous non-compliance issues. There were none.
- 2) Provides a summary of the inspection findings. There were no negative findings.
- 3) Dictates corrective actions required. There were none.
- 4) Provides other inspection findings. There were none.

The MOE Inspection Report confirms that the plant and the collection systems operate in compliance with regulations and in conformance with MOE policies and procedures.

Regulatory Compliance Report (Third-party Review)

The Regulatory Compliance Report provides a summary of the 2011 regulatory compliance undertakings of the various operating groups that are responsible for the delivery of wastewater services. The report reviews documentation of yearly activities and confirms status with respect to compliance with legislative requirements. The report is divided into nine unique sections that represent the services under the authority of Wastewater Services and states the following:

- 1) Robert O. Pickard Environmental Centre (ROPEC)
 - a. ROPEC meets its compliance limits and objectives per the Environmental Compliance Approval.
 - b. ROPEC has Air and Noise Environmental Compliance Approvals.
 - c. There were no raw sewage by-passes at the plant in 2011, for the thirteenth consecutive year.
 - d. ROPEC experienced nine (9) gas venting events (spills). Causes were identified and all were appropriately reported to regulatory bodies.
 - e. ROPEC received nine (9) odour complaints in 2011. The cause was identified, and odour control process filters were refurbished.
 - f. All operators received the legislated training.

2) Biosolids Management

- a. The biosolids meet the permissible metal concentrations for land application.
- b. 49,706 wet tonnes of biosolids were produced, of which 33,548 wet tonnes were land applied.
- c. 90 inquiries about the biosolids program were received by the City.
- d. The biosolids program is operated in conformance with regulations and best practices.

3) Wastewater Collection (Sanitary and Combined Sewers)

- a. The Collection system is operated and maintained in compliance with regulations.
- b. 364 km of sewers were cleaned in 2011.
- c. The system experienced three (3) sanitary sewage spills, for a total of 1,903 m3.
- d. The total volume of Combined Sewer Overflow is 545,000 m3, and the control period volume (April 15 to November 15) is 230,000 m3.
- e. 99.7% of the sewage collected was treated to full secondary treatment, during the control period.
- f. All operators received the legislated training.

4) Stormwater Collection (Stormwater Sewers)

a. 25 km of stormwater pipes were cleaned in 2011.

5) Lees Avenue Stormwater Pumping and Leachate Treatment Plant

- a. The Lees Avenue treatment system is operated in compliance with the Sewer Use By-law.
- b. The Lees Avenue treatment system is operated within the MOE compliance limits.

6) First Response

- a. The First Response group works very closely with the City Call Centre to respond to customer calls.
- 7) Sewer Use By-law Enforcement
 - a. 4,180 Sewer Use Industry Monitoring activities were performed.
 - b. 172 Compliance Measures were carried out.
 - c. 580 Enforcement Responses were completed.
- 8) Pollution Prevention Plan
 - a. The City has a Pollution Prevention Plan, as required by regulation.
 - b. The City is monitoring and reporting, as required, on each component of this plan.
- 9) National Pollutant Release Inventory (NPRI)
 - ROPEC is reporting, as required by regulation, on the release and transfer of substances of concern to the Federal Government.

In summary, the third-party Regulatory Compliance Report and the MOE Communal Sewage Inspection Report indicate that Wastewater Services delivered its mandate in 2011 in compliance with all applicable environmental legislative requirements as well as conformance with current MOE guidelines and policy.

RURAL IMPLICATIONS

Our Biosolids Land Application program, which involves the application of biosolids on farm lands, meets or exceeds all provincial and federal regulations.
