REPORT RECOMMENDATIONS

That the Transportation Committee recommend Council approve:

1. That Section 3(2) of the Encroachment By-law No. 2003-446, as amended, and any fee stipulated in Schedule "A" of the by-law, be waived to allow the Briarbrook and Morgan's Grant Community Association to make landscape enhancements including a rock garden, commemorative plaque and community gateway sign, to the grassed portion of the road allowance at the intersection of Shirley's Brook Drive and March Road; and
2. That the landscaping be completed in accordance with the conditions of Appendix D for Additional Work Agreed upon by the City and the Participant under the Adopt-A-Roadway Program.

BACKGROUND

The Briarbrook and Morgan's Grant Community Association has approached the City for permission to make landscape enhancements to a road allowance in the community of Briarbrook. The proposed enhancements will be in the form of a rock garden complete with a commemorative plaque and a community gateway sign.

DISCUSSION

A rock garden is defined as a permanent surface encroachment under the *Encroachment By-law No.2003-446*, as amended of the City of Ottawa and Section 3(2) of the *Encroachment By-law* stipulates that no person shall erect a permanent surface encroachment.

The City does not provide approvals or permits for road allowance enhancements by private citizens or community groups. The Briarbrook and Morgan's Grant Community Association is currently the adoptees of March Road between Terry Fox to Maxwell Bridge under the City's Adopt-A-Roadway Program. The Community Association is recognized as a legal entity and has agreed to enter into an Appendix D for Additional Work Agreed upon by the City and the Participant under the Adopt-A-Roadway Program with the City.

RURAL IMPLICATIONS

There are no rural implications.

CONSULTATION

The Community Association has consulted with residents in the area and have undertaken to improve the appearance of this entrance to the community as a result of requests from local residents. They have provided information through their newsletter and facebook site. They have also met with City staff who have assisted in preparation of this report.

Planning and Growth Management Department

Staff are in support of the recommendation.

Public Works Department

The Public Works Department is supportive of the report recommendations and will support the Planning and Growth Management Department with the implementation of recommendations subject to approval by Council.

COMMENTS BY THE WARD COUNCILLOR(S)

This site had a sign and landscaping as part of the original subdivision development. It was not maintained and is presently not an attractive entrance to a section of the community. The Community Association has adopted March Road and has regularly picked up litter. They have participated in several greening projects and beautification projects, always with the support and agreement from the City. This project will improve the road at no cost to the City.

LEGAL IMPLICATIONS

There no legal impediments to implementing the recommendations in this report.

RISK MANAGEMENT IMPLICATIONS

There are no risk management implications.

FINANCIAL IMPLICATIONS

The encroachment fee recommended to be waived is \$125 per year.
