Both sides of ID cards are to be copied and current. Health Cards and Social Insurance cards are not accepted

**One** of the following for each family member if you were born **outside** of Canada:

Canadian Passport

Canadian Citizenship Card/Certificate

Canadian Permanent Resident Identification

Confirmation of Permanent Residence in Canada (IMM5292)

Record of Landing (IMM1000)

**Protected Person Status** 

If you **do not** have **status** in Canada, please provide verification of your Permanent Resident Application. Applicants in Canada under the Canada-Ukraine Authorization for Emergency Travel (CUAET) program may provide a temporary resident permit or visitor record.

#### Where you live

**One** of the following to confirm that you live in the City of Ottawa:

Lease or Notice of Rent Increase Mortgage

Property tax bill

Rent receipt with landlord's name and phone number

Letter from landlord

**Two recent** utility bills (from different companies)

**Two recent** Government letters (other than your Tax Information verification)

Documents submitted must be recent within the last 3 months

## **Child custody**

You must provide one of the following custody documents if the other parent of your child does not reside with you or you have a child who is in your temporary care:

Custody/Separation Agreement

**Court Order** 

Affidavit (must be commissioned)

Guardian/Parental Declaration

**Temporary Care Agreement** 

### **Tax information**

**One** of the following for the most recent tax year:

Notice of Assessment (for each parent) and Universal Child Care Benefit Statement (RC62) (if applicable)

Canada Child Benefit (CCB)

Ontario Child Benefit (OCB)

Effective July, only the Notice of Assessment for the previous tax year is acceptable.

Income tax returns/T4 and T1 summary are not accepted.

#### **Newcommers to Canada**

Proof of landing date (Record of Landing [IMM1000] and/or Canadian Permanent Resident Identification) is required if income tax has not been filed.

#### Reason for child care

# **Employed:**

Most current and consecutive paystubs (for one month) **or** 

Letter from your employer confirming the number of hours worked

### Returning to employment from maternity leave, parental leave or other

Letter from your employer confirming return to work date and work hours Employment Insurance (EI) Claim Summary

### **Self-employed:**

Signed Declaration of Self-Employment

Most recent T1 General

Copy of business registration, license, contract or business plan

If self-employed and incorporated, see Employed section.

# **Studying or training:**

School registration with class schedule or

Ontario Student Assistance Program (OSAP) Summary Assessment which states your student status (part time or full time)

### **Receiving Ontario Works:**

You must have an active Participation Agreement with an approved activity.

# Receiving Ontario Disability Support Program (ODSP):

If your spouse is not a person with a disability, verification of reason for child care required.

## Parent or child with special needs

Child Care Fee Subsidy program will provide you with a medical form to be completed by your doctor.

### **Submitting documents**
